In case of joint holders, only the person whose name stands first on the register of members may attend and vote at the AGM, either in person or by proxy.

To be valid, this proxy form, together with the power of attorney or other authority, if any, under which it is signed, or a notarized copy of such power of attorney or authority, must be completed and deposited at the H share registrar of the Company, Tricor Investor Services Limited, at 17/F, Fart East Finance Centre, 16 Harcourt Road, Hong Kong (for holders of H shares), or at the Company's headquarters in the PRC, at A5 Rongjing East Street, Beijing Economic-Technological Development Area, Beijing, the PRC (for holders of A shares), at least 24 hours before the time appointed for holding the meeting or any adjournment thereof.
Completion and delivery of this proxy form will not preclude you from attending and voting at the meeting in person if you so wish.

Shareholders or their proxies attending the meeting shall produce their identity documents.
